They worked until exhausted, lived with few protections and died young. In the West, before mass communication and literacy, the most powerful mass medium was the church, which reminded worshippers that their souls were in danger and that they would someday be meat for worms. Given all this, they did not exactly need their art to be a bummer too. 来源:考试大Which of the following is true of the text? [A] Religion once functioned as a reminder of misery. [B] Art provides a balance between expectation and reality. [C] People feel disappointed at the realities of modern society. [D] Mass media are inclined to cover disasters and deaths. 本题是一道 判断题,可以将选项与原文一一进行比较,然后确定答案 A"宗教一度提醒人们苦难的存在"符合原文意思,从上 面的段落中,尤其是最高级the most powerful...就能判断出这 一点,因此A为正确答案。B"艺术提供了期望和现实之间的 平衡"为干扰选项。为何选A而不选B呢?原因是A为原文直 接表达的选项:过去的人们被苦难的提示所包围,而教堂就

是其中之一。B在原文没有直接表达,只有经过推理才能得到 类似的内容。如何找到原文的直接表达呢?原文的特殊语言 现象,如本文的最高级就可以起提示作用。由此可见,无论 是推理题,还是其他带有推理性质的问题,其答案不过是将 对应原文换个说法而已,不能进行过度推理。又如,来源: 考试大 It 's a rough world out there. [D]Juries tended to find fault with the compensations companies promised. 这是一道事实细节题。根据 问题中的关键词1980s定位一段末句:...(顾客因使用某一产 品受到伤害后)陪审团一般会让有关公司对顾客的不幸负责 这等于说法律保护受伤害的顾客。B" 受伤害的顾客可以受 到法律保护"符合此意,为正确答案。C选项和D选项的内容 明显与原文不符。A"顾客可以通过诉讼免除自己的灾难" 属于过度推理,因为一段四句指出:成功的诉讼可以使顾客 获得损失赔偿(a successful lawsuit might compensate you for your troubles) , 但是可以获得损失赔偿不等于免除了灾难。 例如,一个人因使用某公司产品而受到伤害,他可以通过诉
