始前期准备工作。 原译文: After the bid is awarded, we shall immediately start our advance-phase preparation. 注:项目中标应 为accept a bid or award the contract。显然上述译文把两种表达 法相混淆了。应译为: After the bid is accepted (or the contract is awarded), we shall immediately start our advance-phase preparation. 5.欢迎您参观我们交易会原译文:Welcome you to visit our fair! 注:译文中welcome是动词,因此此句是祈使句形式,省略的 主语为第二人称你(你们),而不是中文所含的我(我们) 之意。应译为: We welcome you to visit our trade fair! 更简洁而 地道的译法是:Welcome to our trade fair! 6.我公司出口工业产 品、化工产品、医药等。原译文:Our company exports industrial products, chemicals, medicines and etc.. 注:etc.等于and so on或and others,已含有and的成分,上述译文无需加上and 一词。应译为:Our company exports industrial products, chemicals, medicines, etc.. 7.我们将委托贵公司作为我公司在毛 里求斯的业务代理。 原译文:We hereby entrust your company to be our business agent in Mauritius. 注:entrust一词在作委托解 时用法为entrust somebody with something or entrust something to somebody。 应译为: We hereby appoint your company to be our business agent in Mauritius. 8.本合同签订之后,签约双方中任何 一方不得将合同内容泄露给第三方。 原译文: Any of the two parties can not divulge the contents of the contract to a third party after the conclusion of the contract. 注:双方中任何一方为either of the two parties,三方(或三方以上)中任何一方才用any of the parties,因本句为否定句,应译为:Neither of the two parties can divulge the contents of the contract to a third party after
