The agent buys and sells for the account of the client, but the client assumes all risk.3. More generally, the relationship between a principal and an agent. agency bank 代理 银行 代开银行 1.国际押汇交易中,一家银行代表另一家银行 (通常在海外) 收取款项,则前者是后者的代理银行。2.参 与发行另一机构名下信用卡的计划,这家银行便是发行机构 的代理银行。3.信用证结算方式的当事人之一,是代理开证 银行换开信用证的银行。开证银行有时要求另一家银行根据 其本身所开的信用证重新换开信用证,以便提高所开信用证 的资信。代开银行通常为出口方所在地银行。 agency bond 机 构债券 A bond, issued by a U.S. government-sponsored agency.

The offerings of these agencies are backed by the U.S. government, but not guaranteed by the government since the agencies are private entities. Such agencies have been set up in order to allow certain groups of people to access low cost financing, especially students and first-time home buyers. Some prominent issuers of agency bonds are Student Loan Marketing Association (Sallie Mae), Federal National Mortgage Association (Fannie Mae) and Federal Home Loan Mortgage Corporation (Freddie Mac).
