Gifts编著的 "Law Dictionary "中将contract 定义为 " contract is a promise, or a set of promises, for breach of which the law gives remedy, or the performance of the which the law in some way recognize as a duty. "根据这一定义,合同是一种承诺,违 反承诺可以得到法律救助,某种意义上法律将履行该承诺看 做是一种补偿。 L.B Curzon 在其编撰的字典 " A Dictionary of Law " 给contract的定义: " Contract is a legally binding agreement"根据这一定义,合同就是有法律约束力的协议。 综合起来,有一个相同点,就是"Contract is an agreement" ,即可将合同说成是 "An agreement which binds the parties concerned "或者说合同说成是 "An agreement which is enforceable by law ",也可以说:Contracts are promises that the law will enforce。 何谓 " Agreement "? L.B " A consensus of

mind, or evidence of such consensus, in spoke or written form, relating to anything done or to be done. "根据这一定义,协议即两个或多个当事 人,为了约定单方责任或相互责任,就财产权利、利益的转 移取得的一致同意。 Contract(合同)和Agreement(协议)是不是 可以互换呢?合同的成立必须具备几个主要因素。它们(要 约和承诺构成的)协议、约因、设立法律关系的愿望和缔约 能力四大部分组成。 L.B Curzon编著的 " A Diction of Law "提 到: "Contract generally involves" 1. offer and absolute and unqualified acceptance (要约和绝对接受) 2. consensus ad idem (意思表示一致 , 也叫meeting of minds) 3. intention to create legal relations (建立合同关系的意愿) 4. genuineness of consent (同意 的真实性) 5. contractual capacity of the parties (合同当事人的缔 约能力) 6. legality of object(标的物的合法性) 7. possibility of performance (履行的可能性) 8. certainty of terms(条款的确定性) 9. valuable consideration(等价有偿) Black 'Law Dictionary"中解

释道: Although often used as synonyms with "contract", agreement is a broader term, e.g. an agreement might lack an essential element of a contact." 即"协议"和"合同"经常用作同义词,但"协 议"这一术语含义更广,例如协议可能缺乏合同的必备条款 (essential clauses/provisions)。 实际使用当中,协议可不受 必备条款的限制,而称为合同的文体肯定少不了必备条款, 有的合同将其单列,称为一般条款(General provisions)。 1999中国《合同法》第十二条规定了八项一般条款,分别是 : 1. title or name and domicile of the parities(当事人的名称或姓 名和住址) 2. contract object(标的) 3. quantity(数量) 4. quality(质 量) 5. price or remuneration(价款或者报酬) 6. time limit, place and method of performance (履行期限、地点和方式) 7. liability for breach of contract(违约责任) 8. methods to settle disputes (解 决争议的方法) 上述解释说明, contract(合同)和agreement(协 议)的概念虽然接近,但使用范围不同,不能互换使用。合同 是协议的重要组成部分,所有合同一定是协议,而协议不见 得都是合同。可以说具备合同成立要求的具有强制执行力的 协议才是合同。 结构特点 合同类法律文件用以规定当事人的 权利与义务,是预防与解决争议的依据。合同英语行文慎密 而准确,历史悠久,深含法律文化底蕴。中文的合同开头一 般先罗列当事人的名称、姓名、住所或营业场所,然后是合 同正文,结尾是当事人印章、授权代表签字、职务及签字日 期。而英语合同一般以下面这类句式为开头:This agreement/contract is made and entered in to this ____ day of (month), ____ (year) by and between Party A (hereinafter called " Party A ")and Party B(hereinafter called " Party B ") 然后是
