- 1、 We'll have the contract ready for signature.我们会准备好合同待签字。
- 2、 We signed a contract for medicines.我们签订了一份药品合同。
- 3、 Mr. Zhang signs the contract on behalf of the China National Silk Import & Export Corporation.张先生代表中国丝绸进出口总公司在合同上签了字。
- 4、 A Japanese company and SINOCEM have entered into a new contract.中国化工进出口总公司已经和日本一家公司签订了一份新合同。
- 5、 It was because of you that we landed the contract.因为你，我们才签了那份合同。
- 6、 We offered a much lower price, so they got the contract.由于我们报价低，他们和我们签了合同。
- 7、 Are we anywhere near a contract yet?我们可以签合同了吗？
- 8、 We sign a contract when we are acting as principals. ("principals" refers to the "seller" and the "buyer")当我们作为货主时都要签订合同。（这里的“货主”指合同中的卖方和买方）
- 9、 I know we (the seller) should draw up a contract and the buyer has to sign it.我们知道我们（卖方）应该拟出一份合同，买方必须签署合同。
- 10、 We should simultaneously sign two contracts, one sales contract for beef and mutton, and the other contract of equal value for the purchase of cotton.我们应同时签两个合同，一个是牛羊肉的销售合同，另一个是等价的棉花购买合同。
- 11、 We both want to sign a contract, and we have to make some concessions to do it.我们双方都想要签署一份契约，因此我们必须做出一些让步。
