Therefore, we can reduce our overall drill bit production costs by devoting the Cookville factory entirely to drill bit production. Since reducing the production costs of individual machine parts is the only way to achieve our larger goal of reducing our overall production costs, dedicating the Cookville factory entirely to drill bit production and shifting all other machine part production to our other factories will help us to attain that larger goal. " Across town in the Park Hill district, the Thespian Theater, Pizzazz Pizza, and the Niblick Golf Club have all had business increases within the past two years. Capital Idea should therefore invest in the Roxy Playhouse, the Slice-o '-Pizza, and the Divot Golf Club, three new businesses in the Irongate district. As a condition, we should require them to participate in a special program: Any customer who patronizes two of the businesses will receive a substantial discount at the third. By motivating customers to patronize all three, we will thus contribute to the profitability of each and maximize our return. Therefore the proposal of investment in the Irongate district is groundless. No investment should be made until

other factors have been considered and the benefit-cost analysis has been made. The programme suggested by the author is reckless or even ridiculous. The possible result can be the opposite of the author 's imagination because the consumers have interest of only one or two of the three stores. The business increases occured in the past two years. No one can guarantee the future profit. The three new companies are not necessarily analogous to those profitable ones. The condition that is required is absurd.
